**It is recommended that participants only bring animals that they deem to be safe in groups of horses, be safe around vehicles and spectators, able to stand quietly and accustomed to loud noises, including but not limited to motors, engines, sound systems, announcers and possibly sirens (Parade route is near the Fire Department). Participants will be riding on roads, and there may be occasions when it is necessary to trot, so if necessary animals should be shod accordingly. Officials reserve the right to excuse any entry at any time, with no refund, for any behavior deemed inappropriate or dangerous.**

This year's parade will feature an official, formal viewing stand with sound system (located at the combined headquarters for the Maryland Horse Council & Equiery on Frederick Road). Each entry will be asked to pause while the announcer reads a brief description about the entry, **do not pause along Parade Route**. This is a great opportunity to promote your organization. Please provide a brief description of your entry (2 to 4 sentences maximum). Include any relevant information such as the purpose of the group, any costume or theme of entry. Descriptions may be condensed for readability at the discretion of the announcer. Use back of form if necessary.

Parking areas will not open before 9 a.m. Details will be provided in your information package with the confirmation of registration.
